1. Call to Order at 10:10 am by Campbell Alexander, President

3. Invited Area 3 R.M. of Gimli Councillor: Richard Petrowski

Loni Beach Area Councillor Richard Petrowski was not able to attend the meeting and arranged for Councillor Thora Palson to attend.

Palson heard many/various concerns of attending residents (including public accesses, signage, road conditions) and requested the incoming LBRA Executive to prepare and provide a summary for Council review. Significant discussion and dissatisfaction expressed surrounding new building structures and variances granted by Council. One in-progress development was noted in particular, not only with respect to its height, to which residents had objected, but also in regards to access to the last remaining Artesian well, located on the adjacent public access.

Mr. Johannson made it known that Council had not sought any input or advice from its own Committee (GMHAC) prior to permitting this particular variance.
