Loni Beach residents' association covers waterfront

Loni Beach is a largely seasonal area but its residents association takes its job seriously. Last fall, the association highlighted a variety of concerns ranging from signage to ditches and road maintenance, among others.

However, many of the concerns raised by Loni Beach Residents Association will have to be brought forward during looming budget talks, though some have been addressed by Coun. Richard Petrowski, the area liaison for the largely seasonal community.

"Most of these [concerns] have been responded to by Coun. Petrowski," chief administrative officer Joann King noted during Gimli council's first regular meeting of the year Jan. 10. "But many will have to go to budget deliberations."

The Loni association would like to have a heritage sign by the lone artesian well left in the sub-

division.

Coun. Thora Palson, who sits on the Gimli Heritage Advisory Committee, says the heritage committee is willing to assist the residents' association. "We will work with them to find a design that's in line with what we have." she said.

In other business at its regular meeting Jan. 10, Gimli council:

* Approved payment of December indemnities and expenses for council members of \$8,710.05. That brings to \$154,345.94 the total received in 2017.

That total amount is very close to the \$153,991.51 council members received in 2016.

* Approved payment of \$300 to the Hudson Bay Route Association for an annual membership. In the past, council has not supported the association but believes now that there will be benefits to joining the group.

"It's a pretty important thing," said Coun. Petrowski. "It [Churchill] is the only northern port in Canada. It think it [membership] will be worthwhile."

He noted that the Gimli-to-Selkirk rail line is deteriorating and the company that owns it is cash poor and struggling to do the required maintenance, not unlike the Denver-based Omnitrax that walked away from its Churchill line last year.

In accordance with Section 36 of The Municipal Councils and School Board Election Act, notice is hereby given that a copy of the VOTERS LIST may be reviewed, by appointment with the SEO, at The Village of Dunnottar Office, 44 Whytewold Road in the Village of Dunnottar. Updates to the Voters List can be made until June 21, 2018.

Updating of the Voters List including:

- (a) adding names of voters who are entitled to have their names on the list;
- (b) deleting the names of persons who are not entitled to have their names on the list; and
- (c) making such other corrections of errors to the list, as required.

VOTER ELIGIBILITY:

A person is eligible to have their name added to the Voters List if they are:

- 1) a Canadian Citizen and at least 18 years of age on election day; and
- 2) a resident of the local authority for at least six months prior to election day; or a registered owner of land in the municipality for at least six months prior to Election Day.

VOTING AS A NON-RESIDENT VOTER:

A maximum of two non-resident property owners per property are permitted to vote in a municipal election. In order to vote, each of these voters must obtain written consent from the majority of the registered landowners and this is to be filed with the SEO prior to June 21, 2018 for inclusion to the voters list.

When voting, you may be required to provide proof of ownership to the voting official. When voting, proof of identity may be requested by the voting official.

A voter's name must not appear on the voters list more than once.

APPLICATION FOR PERSONAL SECURITY PROTECTION:

A voter may apply in writing to the SEO (at the address below) no later than June 21, 2018, to have their name and other personal information omitted or obscured from the voters list in order to protect the voter's personal security. The application may be submitted in person, by mail or fax and must include your name, address and include proof of identity (an official document issued by a federal, provincial or municipal government). Any photocopies must be legible.

All changes to the voters list are to be completed by the close of business (16:30) on June 21, 2018, in preparation for municipal election to be held on Friday, July 27, 2018.
