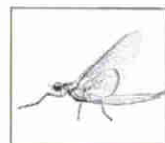

## Final Respects

As this will be the last Newsletter of the 2002-2003 term, we wish to report on the following:

### IT'S THE LAW: BITS & PIECES

There are various Federal, Provincial and Municipal laws affecting our activities in Loni Beach. For example, there is a noise by-law, which prohibits (amongst other things) lawn mowing before 7:00 a.m. (as if ....), a derelict vehicle by-law, which allows for the removal of abandoned vehicles and/or parts and a "neat & tidy" by-law, which controls unsightly premises, "nuisances", junk and rubbish. In addition, a number of laws govern working around water (ie, The Lake), so before anyone thinks about dredging or lake-front landscaping, be sure to contact the local Manitoba Conservation District Office, to avoid the substantial fines.

The RM of Gimli has also recently indicated:

- that building permits for open decks are now required;
- that any construction without an approved permit will result in a penalty fee, effective April 1, 2003;
- that there will be "New Guest Cottage Dwelling" and Outdoor Fire Regulations coming into force soon;
- that there will not be regular garbage pick-up of leaves and clippings throughout the summer, but that you may take these items to the RM Waste Disposal Ground Compost Site;
- that pursuant to the Noxious Weeds Act, weed control is the responsibility of owners, agents or occupants and if weeds are not destroyed, a Weed Control Board representative may enter and destroy, at the owner's expense. The Weed Supervisor, Fred Paulson, will be making systematic inspections and may be contacted at 376-3313 for further information and general advice concerning herbicide methods and uses; and
- that the deadline for removal of all outhouses is August 31, 2003.

### **AND LASTLY**

As you know, since, at least last summer, we have been attempting to resolve the speed limit issue, as well as the matter of removing the "caboose". On May 8, 2003, a formal written request was made to Council and on May 29, 2003, we received its reply. As it concerns the speed limit issue, Council advised "The issue of the speed limit in Loni Beach has been forwarded to the Highway Traffic Board for review and comment" and with respect to the "caboose", Council indicated "... the process of enforcement of the ["neat & tidy"] by-law has begun and will be completed over the next 90 days".
