Minutes of the General Meeting - August 14th, 1976 Loni Beach Advisory Committee - Rural Municipality of Gimli

The meeting was called to order at 8:00 P.M. by the Chairman, Mrs. Dorothy Yates.

A moment of silence was observed for those who had passed away during the previous year: Mrs. Rice, Mr. Erickson, Mr. Harold Steiman, Mr. Sam Lazerek.

The members of the Advisory Committee were introduced and the chairman thanked them for their cooperation and support during their term of office.

The Minutes of the last meeting July 7th, 1975 were moved adopted as read - by Bob Watson and seconded by Ada Orris.

The chairman read her report and asked for its acceptance. This was seconded by Ada Orris.

A lengthy discussion followed concerning the tennis court. Questions were raised regarding maintenance, noise, etc. Mrs. Yates advised the meeting that we had the services of an architect who would design the playground area for us and also send colored slides showing what could be done at very little cost. A row of trees would be planted along the lot line on Vaughan St. and in the spring volunteers would be needed for painting etc.

A concrete perpendicular finger placed on the beach was a point of much discussion. Mr. Mattick advised that anyone doing so could be likel if the matter was reported to the Federal Government. Residents complained that it was impossible to pass by this object. A letter was to be sent to those responsible asking for the removal of the concrete structure or steps to be built over the top. Mr. Wilbur asked the Chairman if there was someone else beside Mr. Adamek who we could deal with. He was advised that Mr. Adamek was in charge and he was the only person whom we could contact. Mr. Wilbur stated that he had never at any time received a truthful answer from him.

Mrs. Yates advised the meeting that Mr. Adamek had felt certain that we would be able to procure the services of Mr. Bob Burkhard again this fall and winter in policing Loni Beach, and that the rural municipality would pay him for doing so.

Dr. Hollenberg requested the building of washroom facilities on the beach area. This would be very unlikely.

Complaints were received regarding dogs running loose on the beach. Mrs. Yates advised that next year there would be proper signs erected regarding this.

Mr. Smith on Loni Ave. complained about the road at the north end of Loni Ave. connecting with Lake avenue being used as a drag strip. He would like to see it taken out now that the roads are back to normal. A turn around should be made at the north end of Lake Avenue as before. The motion was made by Mr. Smith and seconded by Mr. Wilbur. Carried.

Miss Johnston moved to have a bridge built over the Government ditch connecting with Lake Avenue at the south end. The motion was defeated.

Motion to adjourn by Mr. Wilbur - seconded by Dr. Sigmundson.
