
## LONI BEACH RESIDENT'S ASSOCIATION ANNUAL GENERAL MEETING JULY 7TH 1996

  - THE LIST OF ISSUES WE HAVE LOOKED INTO ON YOUR BEHALF ARE:
  - 1. GUARDRAILS ON THE ENTRACE TO LONI BEACH
  - 2. SEWER FOR LONI BEACH- THERE IS A FEASIBILITY STUDY UNDERWAY
- 3. SIGNS FOR POSTING THE SPEED LIMIT- ALSO ONE STATING NO VEHICULAR ACCESS TO PELICAN BEACH
  - 4. DERELICT CARS AND BUILDINGS-LETTER SENT TO THE TOWN COUNCIL
  - 5. DRAINAGE NEAR THE TENNIS COURTS
  - 6. BEACH ACCESS NEAR COMBER AVE.
- 7. WEED CONTROL-REEVE CHUDD SUPPLIED EQUIPMENT AND A NUMBER OF VOLUTEERS DID WORST AREAS AROUND
  - 8. BUILDING OF TWO HORSESHOE PITS SOUTH OF THE TENNIS COURTS

A REPORT IS BEING PRESENTED TO THE COUNCIL TOMORROW.
